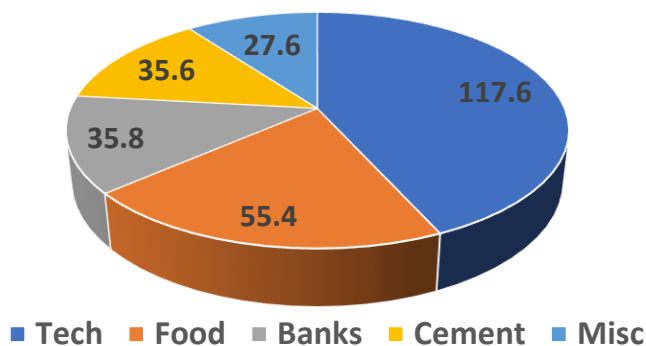
MARKET OVERVIEW

- Going forward, the Index is expected to remain mixed due to the lack of positive trigger in the market.

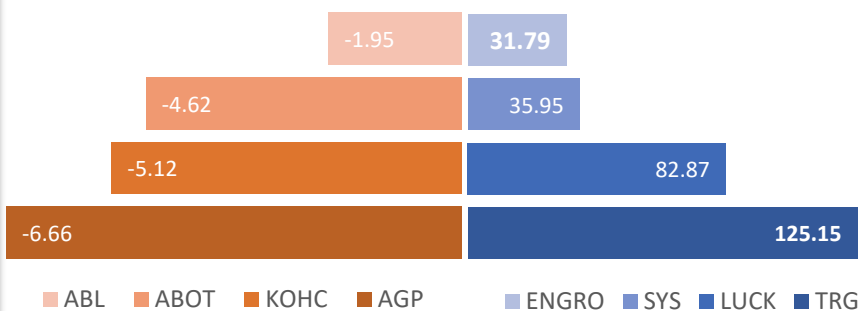
SECTORS OVERVIEW
