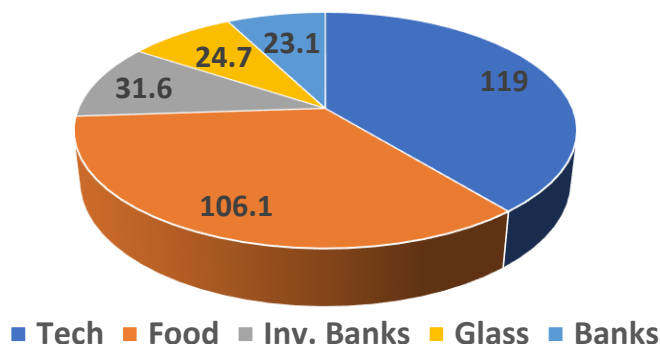
## MARKET OVERVIEW

- Bearish sentiments prevailed at the Stock market as the KSE - 100 Index and stripped off 116pts (0.24% DoD) to settled at 47,447 level. Trading Volumes recorded the decline of 6% to 475Mn shares with the Average Traded Value of Rs. 14.38Bn.
- The volatility prevailed in the market on the likely imposition of strict restriction as the Coronavirus began to rise.
- Going forward, the Index is expected to remain mixed due to the lack of positive trigger in the market.

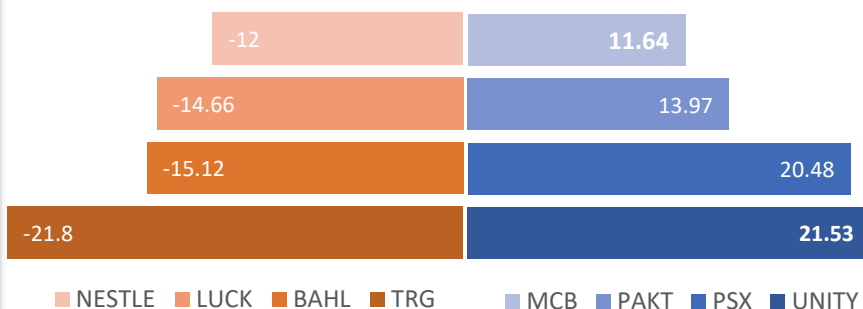
## SECTORS OVERVIEW
