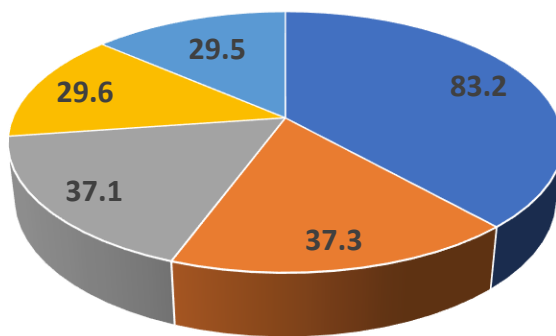
MARKET OVERVIEW

- The **KSE - 100 Index** closed flat with the gain of 14pts (0.03% DoD) to settled at 47,687 level. Trading Volumes declined by 4% to 433Mn shares with the Average Traded Value of Rs. 13.92Bn.
- The Index traded in the positive territory on the encouraging corporate announcements. Moreover the stability in **Crude Oil** prices and the higher **IT Exports** further contributed in lifting up the Index.
- Going forward, the Index is expected to remain mixed due to the ongoing Rollover week.

SECTORS OVERVIEW

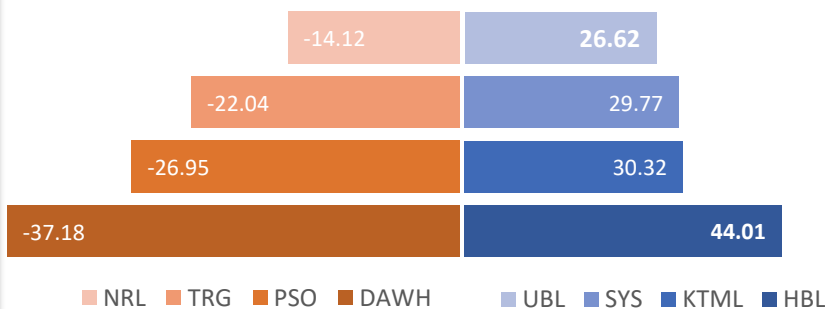
- Sectors that contributed in lifting up the Index includes, Banks, Textile, Fertilizer, E&P, Tech and Insurance that collectively added 216 points.
